TREASURERS' REPORT TO THE EXECUTIVE MEETING OF MONDAY 24TH MARCH 2025 AT MID-DEVON I.B.C.

THE FINANCIAL POSITION IS MUCH AS STATED IN MY REPORT OF 4/11/24WHICH YOU HAVE ALL SEEN, APART FROM ADJUSTMENTS IN OUTGOINGS BECAUSE OF EVENTS PROGRESS NOT AS EXPECTED.

I HAVE ENDEAVOURED TO MAKE AS MANY PAYMENTS DUE PRIOR TO THIS MEETING. THERE IS NOW, THEREFORE A BANK BALANCE OF AS AT 24/3/25. ALL ALLOWANCES AND SOME EXPENSES HAVE BEEN PAID AS APPROVED.

I HAVE THEREFORE ADJUSTED MY FORECAST FOR COUNTY FUNDS TO STAND IN THE REGION OF £ AT THE END OF THE FINANCIAL YEAR BASED ON PREVIOUS YEARS. WHILST APPEARING HEALTHY, IT MUST BE APPRECIATED THAT PART IS DUE TO UNEXPECTED EARLY EXITS IN INTER -COUNTY MATCHES. I THINK THAT POSSIBLY WE WOULD RATHER HAVE SPENT ON SUCCESS IN THOSE COMPETITIONS.

A POSITIVE THOUGHT IS , THAT AFTER REVUE I HAVE DECIDED THAT ALL CAPITATION FEES , MEMBERSHIP AND MILEAGES TOGETHER WITH THE ALLOWANCES BE FROZEN AT EXISTING LEVELS FOR THE 2025/2026 SEASON.
